Roseville Arts' Blue Line Gallery opened its doors to the public in February 2008. The 5000 square foot gallery was conceived by the non-profit Roseville Arts in a bold effort to better serve a community that has sustained and supported its efforts for more than 40 years. The gallery will feature exhibitions of international, national and regional art; workshops and lectures; and educational outreach programs, including a children's gallery, school tours and teacher training at no cost to school districts. Conveniently located in the first floor of the city's new parking garage, the Blue Line Gallery is the cornerstone of the city's revitalization efforts.

### Juror Phil Linhares

Phil Linhares is the current chief curator at the Oakland Museum of Art. Linhares has 41 years of experience in the museum field, including work as Director of Exhibitions for the San Francisco Art Institute and Director of Mills College Art Gallery. He holds a BFA and MFA from the California College of Arts and Crafts.

### Instructions

**Entry Deadline:** July 17, 2008. No entries will be accepted after 5 p.m. on this date.

#### **Eligibility:**

- ❑ Open to all **original** works of art including paintings, sculpture, works on paper, and craft media; prints such as etchings, aquatints, lithographs, photographs, manipulated digital images, etc. **NOTE:** *Reproductions after original works in other media (such as giclées) WILL NOT BE CONSIDERED.*
- ❑ Work must have been produced within the past 2 years and cannot have been exhibited previously in Roseville Arts venues.
- ❑ Size limitations – Artwork and/or artwork crating (2- or 3-D) must fit through doors with clear entry of 94 h x 91 w inches. Weight is limited to 75 lb, or artist must make arrangements with curator to install. Height limit for all artwork is 108 inches (9 feet).

### Instructions, Continued

#### Submitting Images & Entry Form:

- Up to 5 entries per artist.
- JPG images only, no slides or photos. Images must be NO LARGER than 1 MB; and a minimum of 400 pixels for the shortest dimension. Two JPG images allowed for sculpture.
- Choice of delivery. **1) E-mail** images and paperwork to [RosevilleOpenShow@gmail.com](mailto:RosevilleOpenShow@gmail.com), and follow up by mailing signed Exhibit Agreement; or **2) Snail-Mail** completed & signed entry form plus your images on a CD to Blue Line Gallery, 405 Vernon Street, Roseville, CA 95678. EVERYTHING must be received by 5 p.m. on July 15.
- Send nonrefundable \$15 fee per entry in the form of a cashier's check, personal check or money order to "Roseville Arts"; or MasterCard, Visa, American Express or Discover card authorization.

**NOTE:** Plan ahead for shipping costs.

**Shipping, Delivery & Pick Up:** Delivery and shipping of accepted work is the responsibility of the artist. Hand delivery – August 29 and 30, 10am-5pm, to the Blue Line Gallery. Shipping – Work must arrive at the Blue Line Gallery no later than Friday, August 29, 5 p.m. Artwork pick up is on October 11 10 a.m.-5 p.m., or as arranged through Roseville Arts.

**Artwork Selection & Awards:** Juror Phil Linhares will select approximately 60 works for the exhibit from submitted digital images. Notification of acceptance will be mailed the week of July 28, 2008. Winners of the following cash awards will be announced at the opening reception: (1) \$1000 Best of Show, (1) \$500 Juror's Pick, (3) \$100 Merit, and (5) \$50 Honorable Mentions.

**Opening Reception:** Please join us for the opening reception on Saturday, September 6, 6:30-9:00 p.m., at the Blue Line Gallery. Awards presentation at 8:00 p.m.

**Exhibit & Sales:** The Blue Line Gallery will host the exhibit through Friday, October 10, 2008; Tuesdays – Fridays, 10:00 a.m. – 5:00 p.m.; Saturdays, 1:00 – 8:00 p.m.; 3<sup>rd</sup> Saturdays until 9:00 p.m. Roseville Arts will retain a 30% commission on sales for member artists, 40% for non-members. **Insurance:** Artists are responsible for carrying their own insurance. Every reasonable precaution will be taken in handling artwork, but no responsibility is assumed by Roseville Arts' Blue Line Gallery and/or its employees or volunteers for loss or damage to submitted materials from any cause.
